

Terms of Reference for a Lead consultant to build the capacity of selected members of the Partners for Peace Network in Monitoring and Evaluation.

CONTEXT

The Foundation for Partnership Initiatives in the Niger Delta (PIND) is a Nigerian non-profit Foundation established in 2010 with initial funding by Chevron Corporation to support a portfolio of socio-economic development programs for Nigeria's Niger Delta in order to improve standards of living of communities in the region. PIND supports projects in collaboration with a diverse range of donor partners including bilateral and multi-lateral aid agencies, federal and state government agencies in Nigeria, private companies and foundations. With an overarching goal of increasing income and employment in the region, the Foundation uses regional knowledge to understand the root causes of economic instability and forge community owned, market-driven, sustainable results. Its activities fall under two distinct but interrelated program areas:

- An economic development program focused on generating opportunities for pro-poor market development and employment generation.
- o A peace-building program that strengthens conflict resolution mechanisms for enabling integrated peace and economic growth.

To place the synergies more clearly as part of the change logic, the two program areas are reinforced and synergized by the following cross-cutting initiatives which support, enable, measure and communicate the results and achievements of the 2 core pillars of Economic Development and Peace Building:

- A capacity building intervention that will build the service delivery and engagement capacity of government, private sector, civil society and communities.
- An advocacy initiative that improves influencing of policies, practices and programs that premise on an in-depth analysis and understanding of systemic constraints to growth in the Niger Delta region.
- A communications effort that enhances PIND's reputation via multiple and consistent messaging of its transformative approaches, impacts and learning.

PROJECT BACKGROUND

In 2013, PIND established the Partners for Peace (P4P) in Nine Niger Delta States and supported the formalization of the network by supporting the Network to institute a series of structures and systems for governance, management and accountability such as: governance by a Board of Trustees; operational plan and policies; coordination and communications protocols and; physical office spaces. Formal structures and systems have enabled the P4P Network to plan, coordinate and execute interventions that have contributed to a peaceful environment for livelihoods.

Currently, PIND's P4P Chapters have contributed to the transformation of the peace architecture in the Niger Delta. The Chapters have identified and addressed cult related violence, chieftaincy tussles, domestic violence, inter-communal violence, farmers/herders issues, election related violence, communal leadership tussles in over 51 interventions across the 9 states of the Niger Delta. The positive outcome and impacts of the Chapters as commended by stakeholders in the region necessitates the need to strengthen and increase the capacity of the Research and Documentation officers to Document success stories, Best practices, Collate data, Field pictures and Documentaries where necessary for programming, qualitative reporting, Evaluation and Visibility.

Consequently, PIND seeks to engage a lead consultant to build the capacity of selected trainers from the P4P network in Monitoring, Evaluation and Reporting on peace building and conflict management interventions. Specific areas for the training are: development and use of monitoring and evaluation frameworks, strategies and tools; including the formulation of indicators/ targets and tracking of results, Data capturing/collation, and reporting results.

PURPOSE OF THE ASSIGNMENT

The expected outcome of the consultancy service is to train selected trainers from the network who will then increase the capacity of the Research and Documentation officers in P4P Chapters to monitor, capture/collate and report intervention data, evaluate activities/interventions, develop qualitative reports and record success stories/best practices within their localities in line with PIND's Peace building Program strategy. This reinforces the PIND's overall mission of working with partners to build peaceful and equitable economic development in the Niger Delta.

SPECIFIC OBJECTIVES

To achieve this, the lead consultant will work with two members of the network, to develop a monitoring and evaluation framework and tools for peace building interventions. These network members will serve as trainers, who will cascade the learnings to other P4P members.
- Develop training manuals and templates, including presentation slides which will be used to train P4P members. The content of the training materials should include the development and use of monitoring and evaluation frameworks, strategies and tools; including the formulation of indicators/ targets and tracking, data capturing/collation, and reporting results.

SCOPE OF WORK

The scope of work that would be accomplished in the course of the assignment are:

- Training of trainers (select P4P network members)
- Develop training materials and then in in collaboration with P4P trainers refine these
 training materials. Training materials should include presentation slides which will be
 used to train P4P members. The content of the training materials should include the
 development and use of monitoring and evaluation frameworks, strategies and tools;
 including the formulation of indicators/ targets and tracking, data capturing/collation,
 and reporting results.
- Use case studies, role plays exercises, videos, group sessions, and simulations as pedagogical training methods;
- Produce a training report at the end of the training
