

Request For Applications from interested Research Consultants to Identify Advocacy Issues within PIND's Economic Development Program

BACKGROUND

PIND is a Nigerian non-profit Foundation established in 2010 with initial funding by Chevron Corporation to support a portfolio of socio-economic development programs for Nigeria's Niger Delta in order to improve standards of living of communities in the region. PIND supports projects in collaboration with a diverse range of donor partners including bilateral and multilateral aid agencies, federal and state government agencies in Nigeria, private companies and foundations. With an overarching goal of increasing income and employment in the region, the Foundation has four distinct but interrelated program areas. They are:

- An **economic development program** focused on generating opportunities for pro-poor market development and employment generation.
- A **capacity building program** that will build the service delivery and engagement capacity of government, civil society and, communities.
- A **peace-building program** that strengthens conflict resolution mechanisms for enabling integrated peace and economic growth.
- An **analysis & advocacy program** that improves analysis and understanding of systemic constraints to growth in the Niger Delta region.

PROJECT BACKGROUND

The Advocacy for Niger Delta Development project is a component of PIND's Analysis and Advocacy program designed to identify and address advocacy issues emanating from other program areas within PIND which include Economic Development, Peace Building and, Capacity Building programs. The project seeks to address advocacy issues that can lead to systemic changes within PIND's intervention areas.

ANDD is designed to rally a formal and informal network of partners in the development sector, government circles and private organizations to build a strong and cohesive voice to push for improvement in policies and practices in the Niger Delta.

The ANDD projects seek to promote change in knowledge, attitude and, practices at local, state and national level to promote policies and practices that will improve peaceable environment and economic activities. It also seeks to influence the decisions and behaviors of policymakers and market actors towards addressing identified systemic constraints to economic growth in the Niger Delta and finally the project is designed to promote collaboration, coordination and shared learning amongst development partners working in the Niger Delta

PURPOSE OF THE ASSIGNMENT

The primary purpose of this activity is to provide evidence-based data through which PIND can influence government spending to address the needs of stakeholders engaged in economic activities across PIND Economic Development interventions.

This task is to engage a research consultant to identify all the advocacy issues emanating from the Economic Development interventions in the Niger Delta and produce a report with recommendations. In particular, the consultant is expected to recommend advocacy strategies that can bring about changes in or development of policies and practices that can lead to systemic changes across all the Economic Development intervention areas.

SPECIFIC OBJECTIVES

The objectives of this task are to:

- Provide a justification to deepen PIND's government engagement to address issues affecting economic growth in PIND's Market Development value chain interventions and ATED project bothering on WASH, Renewable Energy and Access to technology and agro machinery and the Niger Delta Youth Employment Pathways (NDYEP)
- 2. Clearly articulate the advocacy issues that are affecting the growth sectors and their support systems that PIND is intervening through the Economic Development programs
- 3. Provide actionable recommendations and strategies that can be applied in the Niger Delta to address strategic advocacy issues
- 4. Produce a draft intervention plan for the implementation of the proposed advocacy strategies

SCOPE OF WORK

The scope of this activity involves

1. A broad understanding of the advocacy related constraints all the systemic constraints affecting PIND's Economic Development intervention in the Niger Delta



- 2. Engagement of all relevant stakeholder comprising relevant PIND intervention managers, market actors, beneficiaries of PIND interventions, intervention and implementation partners across the nine States in the Niger Delta to identify the advocacy issues within their respective sectors
- 3. Quantitative and qualitative analysis of findings, production of report and design of implementation strategy
